- (C) Selections will be based on a combination of both Academic Standings and participation in the Hockey Newfoundland and Labrador Officiating Program.**

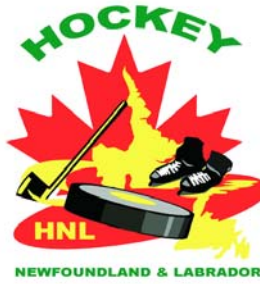
