## **WILL YOUR ASSOCIATION, TEAM OR LEAGUE BE INVOLVED IN FUND-RAISING THIS COMING SEASON?**

The Lotteries regulations require that when a hockey organization applies for a lottery license, we, Hockey Newfoundland and Labrador, are asked to certify that the Association, Team or League is, in fact, a member in good standing of the Provincial Association.

In order for our Association to certify that you are indeed a member in good standing, we require that you complete the membership application provided, accompanied with a \$5.00 annual membership fee as stated in our Constitution under Article 5, A.

Upon receipt of the membership application and fee, we will forward the necessary certification to the Department of Tourism, Culture and Recreation who in return will send an approved copy to you, which can be used without delay in applying for a lottery license.

The process of applying for a lottery license takes some time, so we encourage that you send your application NOW to avoid any further delay.
